Whereas R.Austin Raj (now deceased) S/o.V.Rajamoni, formed R.P.Educational and Charitable Trust registered as document No.37/4 of 2003 of Palliady Sub Registry and the same was subsequently amended by registering a supplemental

And whereas the board of trustees are desirous of reconstituting the trust and the power of the trustees on account of the death of the then Chairman of the Trust Mr.R.Austin Raj and another trustee of the board Mr.R.Renjit Singh.

Now this Supplemental Trust Deed witnesses as follows:

1) **The board of trust is reconstituted as follows:**

2) The chairman of the trust is entrusted with the following powers in addition to the powers mentioned in the original trust deed registered Document No.37/4 of 2003.

a) The bank account or accounts in the name of the Trust shall be jointly operated by the Chairman and the Treasurer or person duly authorized in this behalf by the Chairman with the approval of the board of trust.

b) The Chairman shall have power to frame rules and regulations to administer the property of the Trust and

to amend the same from time to time



c) The Chairman may apply to obtain any loan from bank or other financial institutions or persons for any specific purpose of the Trust on such terms and conditions as the Chairman may deem fit in the best interest of the Trust and shall have power to pledge and or hypothecate the securities and other movable assets. He is also empowered to execute deeds of conveyances or similar deed for and on behalf of the trust in favour of banks and or financial institutions and do all necessary act/s in furtherance of the execution of such deeds.

d) The Chairman shall have power to invest, purchase, withdraw, sell, manage, redeem and compromise matters arising out of the Trust and its properties.

e) The Chairman is empowered to appoint necessary staff and to incur necessary expenditures for the purpose of carrying out the objectives of the Trust and all costs and expenses incidental to the administration of the Trust.

f) The Chairman may appoint Secretaries, Managers, Lawyers, Solicitors, Auditors, Architects, Engineers, Surveyor or other employees for the purpose of management and supervision of the Trust Estate, collection of rents, maintenance of accounts and records of the Trust and to dismiss or dispense with the services of such personnel.

g) The Chairman shall have full power to compromise or compound all actions, suits and other proceedings and

Estate and/or Trust properties and to refer any such differences or disputes to arbitration and to adjust and settle all accounts relating to the Trust Estate and/or the Trust properties and to do all other acts and things fully and effectually without being liable or answerable for any bonafide loss occasioned thereby.


- h) The Chairman shall have the absolute power to carry on the day to day activities, to determine from time to time, the particular charitable objects and purposes for which the funds of the Trust shall be used and to allot and allocate from time to time each of the objects such proportion of the funds as they deem fit and also to incur all expenditure necessary or in his option useful for carrying out the objects of the trust.
- i) All receipts and payments by and in favour of the trust and the institutions run by the trust shall be acknowledged by the Chairman and the Treasurer Negotiable instruments, bill of exchange, promissory notes, cheques, receipts etc., shall be jointly signed and acknowledged by the Chairman and treasurer
- j) The Chairman is responsible to do all necessary acts to carry forward the primordial objects described here below of the trust that was included in the supplemental trust deed registered as document No.48/4 of 2010 at Palliyadi Sub Registry:
- i) To promote the cause of value based education of the Christian Religion Minority community in the rural areas in general in a manner most suited to the social - cultural needs of the Christian minority community in Tamil Nadu.
- ii) To train the Christian minority youngsters and to equip them to face the new and emerging in







- a) The treasurer shall have power to operate the bank account along with the Chairman.
 - b) All receipts and payments in favour of the trust and the institutions run by the trust shall be acknowledged by the Treasurer and Chairman Negotiable instruments, bill of exchange, promissory notes, cheques, demand drafts, receipts etc., shall be jointly signed and acknowledged by the Chairman and Treasurer
- 4) There are no changes in the original trust deed and its supplemental trust deeds except the above. All other matters in the original trust deed number 37/4 of 2003 shall be the same.
 - 5) There is no change in the location of the trust office and the corpus fund of the trust. The trust is functioning at the very same rental building mentioned in the original trust deed and the corpus fund is Rs.1000/-.
 - 6) This Supplemental trust deed forms part of the original trust deed registered as document No.37/4 of 2003.
